To qualify for a wholesale account, your business must meet the following requirements:

## 1. Maintain Current Business Information

Maintain accurate and up-to-date company information throughout the term of your reseller relationship with Magna-Tiles<sup>®</sup>. For example, if contact information changes, you open a newstore location or change your name, notify us immediately.

## 2. Disclose All Locations that Carry Magna-Tiles<sup>®</sup> Products

Qualifying retail locations can only be one of the following: your brick-and-mortar store(s), your commerce-enabled website, or temporary storefronts (events, pop up stores, etc)

## 3. Sell on Approved Retail Websites Only

Must only take orders via publicly accessible ecommerce enabled web pages hosted on approved websites owned and operated by your company.

Selling on 3rd party sites (ebay, etc), drop-ship accounts (Buy.com, Newegg.com, Overstock.com, etc.), classified sites (Craigslist.com, Facebook Marketplace, etc.) or direct messages on forums is strictly prohibited. Selling on Amazon.com under your company name requires approval. Selling on Amazon using Fulfillment by Amazon (FBA) services is strictly prohibited.

## 4. Report Sell-Thru

Be prepared to report sell-thru information by SKU & approved retail location upon request.

# 5. Abide by Magna-Tiles<sup>®</sup> Trademark & Brand Policy Guidelines.

Must agree to comply with Magna-Tiles<sup>®</sup> and Magna-Qubix<sup>®</sup> Trademark and Brand Policy and represent yourself as an authorized retailer in all online advertising and sales collateral.

Setting up businesses, registering domain names, or social media usernames that contain any of Magna-Tiles<sup>®</sup> or Magna-Qubix<sup>®</sup> trademarks is strictly prohibited.

Do not use unapproved marketing materials (such as photos & copy) for Magna-Tiles<sup>®</sup> or Magna-Qubix<sup>®</sup> products. Do not advertise Magna-Tiles<sup>®</sup> or Magna-Qubix<sup>®</sup> products in ways that violate the terms of these Reseller Requirements or Minimum Advertised Price Policy.

## 7. Sell to Customers within Assigned Geographic Territory Only

Do not sell Magna-Tiles<sup>®</sup> or Magna-Qubix<sup>®</sup> products to other retailers, B2B accounts, wholesalers, or freight forwarders. Please sell to your end consumers only.

# 9. Only Purchase Magna-Tiles<sup>®</sup> and Magna-Qubix<sup>®</sup> Products Directly From Magna-Tiles<sup>®</sup>

Do not buy Magna-Tiles<sup>®</sup> or Magna-Qubix<sup>®</sup> products from other retailers, or from sources not explicitly endorsed by MVW Holdings, Inc.

## 10. Only Sell Magna-Tiles<sup>®</sup> and Magna-Qubix<sup>®</sup> Products in Original Packaging

# **Minimum Advertised Price Policy**

Dear valued customer,

In order to protect the investment of our high-quality retailers, Magna-Tiles<sup>®</sup> has adopted a MINIMUM ADVERTISEDPRICE POLICY (MAP Policy). Magna-Tiles<sup>®</sup> has established this MAP Policy due to the fact that reseller advertising and sales practices that promote our products primarily on the basis of price could be detrimental to resellers' service and support efforts and competitive position. Such activities can be harmful to our brands' reputation and competitiveness, and allow some resellers to take advantage of the service and support efforts of others. Magna-Tiles<sup>®</sup> believes that these practices are unfair and thus discourages such efforts.

Magna-Tiles<sup>®</sup> will not do business with any reseller, as to the products covered by this MAP Policy, if that resellerintentionally advertises any MAP Product below its MAP Price. Magna-Tiles<sup>®</sup> is confident that this program will strengthen its competitiveness and benefit all of its resellers.

#### **Policy and Guidelines**

**1.** Magna-Tiles<sup>®</sup> reserves the right, in its unilateral discretion, to take other action with respect to any seller thatviolates this MAP Policy.

2. The MAP Policy will be enforced by Magna-Tiles<sup>®</sup> in its sole discretion.

**3.** Magna-Tiles<sup>®</sup> recognizes that any authorized account can make its own decisions to advertise and sell any Magna-Tiles/Magna-Qubix brands products at any price it chooses without consulting or advertising Magna-Tiles<sup>®</sup>. Magna-Tiles<sup>®</sup> similarly has the right to make its own independent decision regarding product allocations and retailer participation as a member of the Magna-Tiles<sup>®</sup> Wholesale Account Program - at any time.

**4.** Magna-Tiles<sup>®</sup> will maintain an updated MAP Products list of those products that full under this MAP Policy. Magna-Tiles<sup>®</sup> reserves the right to update or modify this list at any time.

**5.** All products will have a MAP retail price. Listing a price other than the MAP retail price next to the featured MAP Product in any advertising will be viewed as a violation of this MAP Policy. This MAP Policy applies to all advertisement of MAP Products in any and all media, including, without limitation, flyers, posters, coupons,mailers, inserts, newspapers, magazine catalogues, mail order catalogs, internet, or similar electronic media including websites, forums, email newsletters, email solicitations, television, radio, and public signage. Such website features as "click for price", automated "bounce-back" pricing emails, pre-formatted e-mail responses, forms, automatic price display for any items prior to being placed in a customer's shopping cart, and other similar features are considered to be communications initiated by the retailer (rather than the customer) and thisconstitutes "advertising" under this MAP Policy.

**6.** From time-to-time Magna-Tiles<sup>®</sup> may permit retailers to advertise MAP Products at prices lower than the MAP retail price. In such events, Magna-Tiles<sup>®</sup> reserves the right to modify or suspend the MAP retail pricewith respect to the affected products for a specified period of time.



7. It shall be a violation of this MAP Policy to include in any advertising for Magna-Tiles<sup>®</sup> brand products anyadditional discount, coupon, gift card, or incentive (whether in the form of a special event, promotion, term of doing business or otherwise) that translates into an immediate price reduction, where the cumulative effect would be to reduce the advertised price of any MAP Product below MAP.

8. If a reseller with multiple store locations violates this MAP Policy at any particular store location, then Magna-Tiles® will consider this to be a violation by all of the reseller's locations.

9. Although resellers remain free to establish their own resale prices, Magna-Tiles<sup>®</sup> reserves the right to cancel all orders and indefinitely refuse to accept any new orders from any resellers following Magna-Tiles<sup>®</sup>'s verification thatsuch reseller has advertised any MAP Products at a net retail sales price less that the then-current MAP retail price established by Magna-Tiles<sup>®</sup>, or if retailer has violated this policy in any other way.

## SHIPPING

## CLAIMS FOR DAMAGES OR SHORTAGES

Loss claims for visible and/or hidden damage in the shipment are the responsibility of the customer and must be made to the freight carrier immediately. To ensure claims are approved, any damages or shortages must be reported to the driver and Magna-Tiles at the time of delivery before the driver leaves. Magna-Tiles will not issue a credit for shortage or damage claims that have not been reported to the transportation carrier and Magna-Tiles at the time of delivery. Shipments received on pallets must be checked before signing the bill of lading. Small Package (UPS) claims for shortages or damages must be reported within 5 days of receipt from delivery.
